Supply – Sustainable production

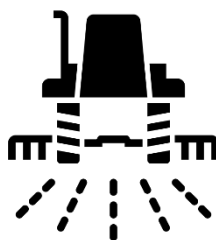
Established by the unification of **two companies**, linked to the **vegetal world**.

Compliance with basic requirements

For each raw material, we have quality documents, that specify our technical requirements.

We educate our suppliers to commit to **ethical principles**. Carrying on;

- The defence of human rights,
- The abolition of child labour and forced labour,
- Occupational Health and Safety,
- Justice and loyalty in practices,
- The preservation of the environment.

In case of suspicion, we reserve the right to audit them.

We carry out an **annual evaluation** of all our suppliers to guide our actions, our choices for a rigorous selection in accordance with our needs, our values and our commitments.

Quality

We do everything we can, **to preserve the best** of our plants and fruits. Our manufacturing processes (harvesting, drying, sorting, etc.) are studied to ensure that the product is not distorted.

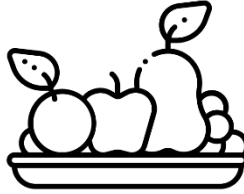
We work on the **continuous improvement** of our raw materials taking into account the specifics of our customers and the characteristics associated with their needs.

Our quality management systems checks at every step of the manufacturing process. In this sense, our Quality teams ensure compliance with regulations and specificities, in particular by carrying out physical, chemical and microbiological controls to guarantee the quality of the products. We also monitor the presence of foreign objects throughout the production process to ensure exemplary safety and purity.
